

FUND SWITCH AND REDIRECTION FORM.

IMPORTANT INFORMATION AND CONDITIONS

1. Before you fill out this form did you know that you can manage your pension funds online? Why not log onto www.legalandgeneral.com/workplacebenefits/employees and take a look now?
2. We will process switch and redirection instructions on the same day if we receive these before 12.00 noon. Any that we receive after 12.00 noon will be processed on the following working day.
3. At the time of writing we do not charge for switches or redirections. We will let you know if this changes.
4. If you are switching out of With Profits before your selected retirement age, we may reduce the value of your investment by a market value reduction. Please refer to your With Profits brochure for more details. With Profits is not available as an investment under the Stakeholder Pension Scheme.
5. If you invest in a fund that invests in property, it may be necessary to defer encashment of units during periods when property is not easily sold. The maximum delay is six months.
6. You can only invest and pay contributions into one lifestyle profile at a time. This means that you must always include a full 100% switch and redirection of contributions if you wish to make any lifestyle profile investments.



PLEASE NOTE

Protected Rights are funds that have been built up from being contracted out of the State Second Pension (formerly SERPS). The Government stopped contracting out from 6 April 2012. From this date, any Protected Rights you have will be known as 'Formerly Protected Rights'.

GLOSSARY OF TERMS

Regular contributions

These are paid to Legal & General on a regular basis and may be amounts from yourself and/or your employer.

Single contributions

These are one-off amounts that are not sent to Legal & General on a regular basis. They may be amounts from yourself and/or your employer.

Benefit Type

This is how we describe the different types of contribution you could pay into your plan. This will be your regular, single or contracted-out rebate contributions.

Switch

This is if you want to change the fund allocation of your existing contributions.

Redirection

This is if you want to change the fund allocation of your future contributions.

Lifestyle profile

This is an alternative investment option to choosing an individual fund, or funds. You can only be in one lifestyle profile at a time and you also cannot invest in any other funds at the same time.

Fund Code

Each of the funds available to you has a unique four digit numerical code. A description of the funds along with their codes can be found in the 'Investment Options' brochure which is available on line.
