Charge	Description
Fund Management Charge (FMC)	This represents the combined total of the Investment Management Charge (IMC) and Additional Expenses (AE). This charge is accounted for in the unit price and is reflected in the value of your fund.
Investment Management Charge (IMC)	This is a charge made by the fund manager for managing the fund.
Additional Expenses (AE)	This is a variable charge and covers various fees and expenses that fund managers may have to pay. AE can vary throughout the year.

In addition to the charges for investing your contributions, there is also an Annual Management Charge (AMC).
